### ART. 1 SUBJECT

Francigena Service S.r.l, with the present notice, establishes the list of suppliers for the entrustment of services.

### ART. 2 OJECTIVE

The list will be utilised as a tool to identify the economic operators qualified to supply heritage and services if they fulfill all conditions. The authority of the Francigena Service S.r.l. remains secure when dealing with suppliers and services which, for the particular subject or the requested specialisation, does not render the use of the list possible, that is to say, if on the basis of its own knowledge of the market it believes it would be useful to widen competitiveness as opposed to the listed suppliers, to invite or consult other entities considered to be suitable, as well as those registered in the section pertinent to the self-same.

Moreover, Francigena Service S.r.l. reserves the right to select suppliers considered suitable even if they are not registered on the supplier list in the case of commodity-related categories for which an economic operator has not been registered or the number of enrolees are scarce or operators that registered which, of the unquestionable opinion of Francigena Service S.r.l., for technical, financial, organisational characteristics (with particular reference to the execution time of works and/or the completion of services), are not able to gurantee the execution of the supply requested.

The registration to the list does not require any obligation for Francigena Service S.r.l, who will be able to decide, in its unquestionable opinion, without the enrolee of the supplier list expressing exceptions, or contesting the lack of appeal to the category of which it is registered.

## **REQUISITES REQUESTED FOR REGISTRATION**

Those who may register for the list of suppliers include: individual entrepreneurs, artisans, societies, cooperatives, consortiums, or groupings of the aforementioned, as well as professionals. The subjects must have experience in the requested commodity-related category and, in the moment they present their request, they must be in possession of the following requisites:

- requisite of professional eligibility;
- requisite of economic-financal ability;
- requisite of technical-professional ability.

The economic operator attests that, under their own responsibility, the posession of the aforementioned requisites, utilising, under penalty of exclusion, the *fac-simile* attached (Attachment1) to the current notice.

The registration in the aforemetioned list does not exclude the possibility of, during market research, the request of docments considered useful or updated even if they are already in the possession of Francigena Service S.r.l.

# ART. 5 MANNER OF REGISTRATION

The economic opertors which intend to register themselves to the list must address their application and a signature of legal representation exclusively utilising the *fac-simile* attached to be compiled in every respect.

# ART. 6 GRANTING THE REQUEST

The applications attained and presented in accordance with the process described will be instructed by the responsible for compliance and procedure who, if necessary, will request additional integration, clarifications or documentation. Once the subsistence of the requested requisites hav been verified, the responsible for complianc and procedure will prepare the supplier list which will be approved by the EAVF Executive Board.

#### **ART. 9**

### **CANCELLATION OF THE FROM THE SUPPLIER LIST**

Francigena Service S.r.l will arrange cancellation from the list, besides upon the request of the registered supplier, in the following cases:

- loss of or false declaration in regards to one or more requested requisites;
- lack of supply of goods and/or services commissioned in the absence of verified impediments of force majeure;
- non-fulfillment of supply of goods and/or services commissioned or quantative/qualitative discrepancy of the supply and/or service;
- lack of presentation of the offer in the face of two consecutive invitations without suppliers in respect to written motivation.

# ART. 10 TREATMENT OF PERSONAL DATA

In accordance with D.L. 196/03 and s.m.i. "safeguarding of people and other subjects regarding the treatment of personal data", the personal data supplied by the economic operators will be regarded soley for the management of the present notice and for registration to the supplier list and kept with the administration of the Francigena Service S.r.l. The treatment of such data is compulsory in the evaluation of participation requisites, the penalty being the exclusion for the selection process. Those interested will be able to practice their right to art.13 of the aforecited law, among which illustrates the right to access to data which concerns them, as well as other complimentary rights among which the right to rectify, update, complete or delete inaccurate or incomplete data, or data collected in non-compliance with the law.
